

# WELCOME TO THE MARION BAY CARAVAN PARK

Welcome to the Marion Bay Caravan Park. We hope you enjoy your stay.

To help make your stay and others more enjoyable, we ask that you comply with the following conditions.

**Reception is open daily from 8.30am until 6pm. Reception may be un-staffed on occasion for park duties;  
Please call 0439 845 015 for assistance. Please note: Arrival time is 2pm and departure time is 10am**

**FEES** - Fees are payable in advance and **NO** refunds are given for shortened stays. Sorry, if you leave early.

**VEHICLES** - The speed limit for any vehicle is walking pace only to a maximum of 10km/h. Only registered vehicles may enter the park. Speed limit is for the safety of children and patrons.

**VISITORS** - Visitor's cars are to be left outside the park. Patrons are responsible for their visitor's behaviour and they are to leave the park by 10pm. Extra fees apply for overnight stays or showers.

**SITES/CABINS** - To ensure the comfort of everyone in the park, the number of persons on any site is limited to six. We allow one caravan and annex or one tent and one vehicle per site. The number of persons accommodated in a cabin may not exceed the number of beds provided in the cabin. All cabins are non-smoking (ashtrays are provided outside the cabin for your convenience). No pets allowed with any cabin accommodation.

**SMOKING** - The Park has a non-smoking policy in all shared areas. This includes cabins, camp kitchen, barbecue areas, playgrounds, amenities block, etc. Smokers are asked to respect other guests when smoking.

**PETS - PETS ARE NOT PERMITTED IN CABINS.** Pets are allowed under strict control when using your own caravan/tent at the discretion of Park Managers. Pets must be kept on a leash at all times. Pets must not be left unattended in the Park. Pets must not disturb other patrons. Owners must clean up after their pets immediately. **FAILURE TO COMPLY** with these rules will result in **EVICTED FROM THE PARK.**

**CHILDREN** - Your children and those in your care **MUST** be supervised by parents/adults at all times. Children under the age of 12 years will be accompanied by an adult to the playground and other facilities in the park

**BIKES ETC** - All normal road rules apply within the park. Helmets must be worn when riding bicycles, skate boards, roller blades, etc. For safety reasons no bicycles, skate boards, etc are to be used after sunset or around the amenities and camp kitchen.

**PLAYGROUND AND KANGAROO JUMPER** - Children must be supervised. Dangerous behaviour will **NOT** be tolerated. Patrons use the facilities at their own risk. No food, drink, glass or smoking in the playground. Footwear is NOT to be worn on the Kangaroo Jumper. **DO NOT** use the Kangaroo Jumper with wet. **CAUTION:** The Kangaroo Jumper surface can become **VERY HOT.**

**BBQ'S & CAMP KITCHEN** - Please leave BBQ's in clean condition. Please do not pour liquids down the BBQ's. Please remove all rubbish and leave these areas in a clean tidy condition after use.

**RUBBISH** - Please keep our park looking neat and tidy by keeping your site/accommodation neat and tidy. Please place cans, bottles in the recycling bins provided. All other rubbish to be placed in the wheelie bins. Fish rubbish to be wrapped and put in plastic bags and placed in the bin at the fish cleaning bay

**WATER** - The park uses desalinated water. Please use water wisely. **STRICTLY NO WASHING OF VEHICLES, BOATS OR RV'S.**

**QUIET TIME:** To ensure the enjoyment of everyone. Guests are requested to restrain from any type of loud or offensive behaviour. **NOISE IS TO BE KEPT TO A MINIMUM BETWEEN 10PM AND 7AM.** If you have any problems with the conduct of other guests, please see park management or **EMERGENCY** after hours, 0439 845 015.

**FIRE REGULATIONS** - Campfires are permitted in a contained vessel during non-fire danger season. For safety reasons, **ALL** draw bars for vans must face the roadway. Gas cooking only on a total fire ban day.

**COMPLIANCE** - In the interest of all guests, failure to comply with these park rules may result in eviction from the park. Management reserves the right to cancel any permit at any time. Council reserves the right to charge guests for any cost/s associated with any extra cleaning or damages.

**DUMP POINT** - There is a designated dump point in the park (see map overleaf). **DO NOT** use amenities to dispose of waste.

## EMERGENCY EVACUATION PROCEDURE

### Should a fire occur, the following actions should be undertaken

Assist anyone in immediate danger \* Raise the alarm immediately \* Consider the fire attack only if safe to do so \* Telephone 000 \* Proceed immediately to the emergency assembly area \* Should anyone's clothing catch fire: stop immediately, do not run. Drop to the ground. Smother the flames by rolling on the floor or ground. Should anyone suffer burns: cool the burns immediately with water (continuously for at least 10 minutes). Do not remove any clothing in burnt area. Keep casualty calm until ambulance arrives. All cabins and the camp kitchen area have fire extinguishers and fire blankets.

**Please make sure you are totally aware of this procedure**
